The core improvements will be upgrading the anaerobic digestion system with Thermal Hydrolysis Process. To facilitate that upgrade, components of the Blue River Solids Complex will be rehabilitated, replaced, and modernized, including the electrical system, HV AC system, sludge screening and pretreatment, east and west holding tanks, anaerobic digestors, sludge heat exchangers, boilers, dewatering equipment, sludge storage facilities, cake storage facilities, and biogas treatment.
