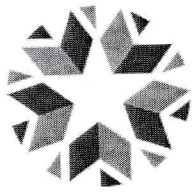

Follow these easy steps to register for OkTAP:

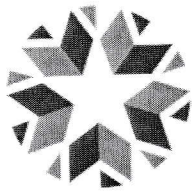
1. Have your 13-digit OTC account number and FEIN or SSN available.
2. Go to **www.tax.ok.gov** and select "Register Here".
3. On the OkTAP page, click on "Sign Up".
4. Enter personal information, as prompted.
5. Create a logon ID and password.
6. Provide customer and account information.

After registering, you can file, pay and manage your taxes at one convenient location.
