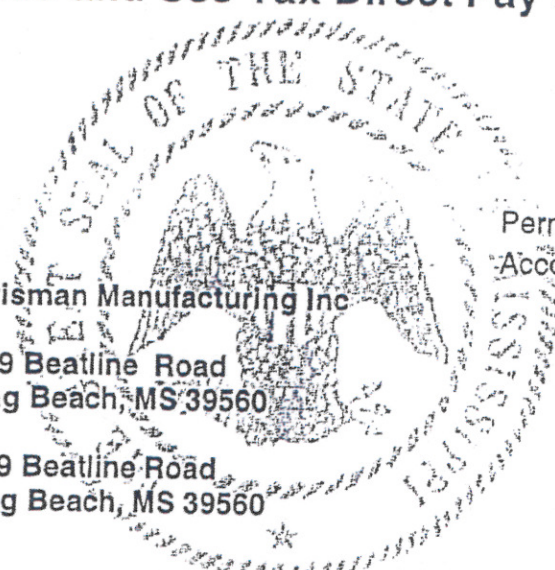

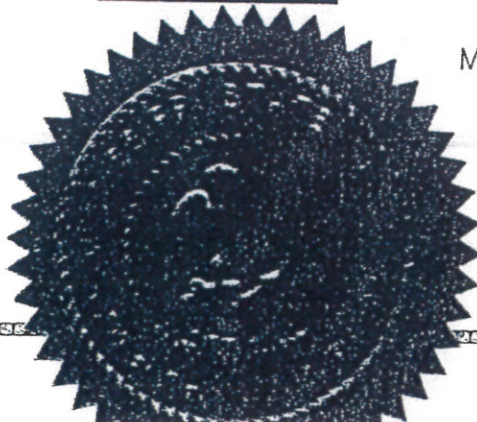

NUMBER SHOWN BELOW. THIS PERMIT AUTHORIZES THE HOLDER TO PURCHASE
MATERIALS OR SERVICES FOR RESALE, IN THE REGULAR LINE OF BUSINESS,
EXEMPT FROM TAX.
