A contractor may not directly authorize subcontractors to make purchases on your behalf. Instead, you should provide a separate permit copy to each contractor or subcontractor that you wish to make purchases on your behalf.

You and/or your contractor(s) are responsible for paying sales and use taxes on items that do not qualify for exemption. All purchases may be audited by the Department of Revenue. Intentional misuse of this permit subjects you or your contractor to payment of the tax plus a mandatory 200 percent penalty and is a third-degree felony punishable as provided in ss. 775.082, 775.083, or 775.084, Florida Statutes.
